School Facility Conditions and Planned Improvements (Most Recent Year)

Park Dale Lane Elementary School provides a safe, clean environment for students, staff, and volunteers. School facilities were built in 1975 and currently include a library/media center, multipurpose room, staff lounge, 31 permanent classrooms and three playgrounds. Recently, Park Dale Lane was under construction to provide a newly designed office building, and the entire campus is being refreshed with paint, new gardens and design features. All classrooms received four solar tubes and provide the classrooms with natural light.

District maintenance supervisors are proactive and conduct inspections at school sites on a continual basis. Repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority. District maintenance has indicated that 100% of all toilets on school grounds are in working order.

All schools within the Encinitas Union School District will have various site upgrades during the next 3-5 years based on the Capital Facilities and Technology Plan submitted as a component of Proposition P that was passed by the voters in November 2010. Thanks to the passage of Prop P, this year our school will receive solar tubes to reduce current electrical usage.

School Safety Plan (Most Recent Year)

Safety of students and staff is a primary concern of Park Dale Lane Elementary School. The school is in compliance with all laws, rules, and regulations pertaining to hazardous materials and state earthquake standards. The school’s Disaster Preparedness Plan includes steps for ensuring student and staff safety during a disaster. Three-in-one drills (lock down, earthquake and disaster drills) are conducted on a monthly basis throughout the school year. A district-wide disaster drill is held once each year. Monitoring of school grounds is performed by noon supervisors and assigned staff before, during, and after school. All visitors must sign in at the office, obtain a visitor’s pass, and sign out upon leaving.

The Comprehensive Safety Plan was developed by the school in consultation with local law enforcement in order to comply with Senate Bill 187 of 1997. The plan provides students and all staff a means to ensure a safe and orderly learning environment. Components of the Comprehensive Safety Plan include the following: child abuse reporting procedures, teacher notification of dangerous pupil procedures, disaster response procedures, procedures for safe ingress and egress from school, sexual harassment policy, and dress code policy.

Park Dale Lane Elementary School reviews the plan annually and updates it as needed. The current plan was reviewed and revised in September 2014.
