

TEACHER ON SPECIAL ASSIGNMENT (ToSA) - MULTI-TIERED SYSTEM OF SUPPORTS (MTSS)

Job Description

DEFINITION:

Under the direct supervision of the site administrator and in collaboration with the Coordinator of Enrichment and Intervention Programs, coordinate and implement the district-wide Multi-Tiered System of Supports (MTSS) plan at the school site that includes academic, behavioral and social emotional support; provide support to site staff in running the targeted intervention program, and collaborate with district staff to ensure intervention programs are evidence-based, effective, equitable and implemented with fidelity.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

- Ensures all student interventions are evidence-based, targeted, provided with fidelity, culturally responsive, and developed and implemented equitably.
- Serves as a resource in identifying instructional strategies and interventions to improve achievement for all students.
- Develops and oversees systems to monitor progress of all students receiving intervention to ensure continued growth.
- Develops schedules for intervention services for students.
- Completes systematic data analysis to drive flexible groupings and decision making.
- Provides direct instruction with whole class, small groups and individual students.
- Consistently provides direct Tier 2 and/or Tier 3 instruction to student groups.
- Participates in EUSD equity committee work and provides on-site professional development related to equity.
- Attends Educational Services Department meetings with district level ToSA-MTSS team.
- Provides on-site staff development to ensure that all teachers are knowledgeable about ELA and Math instructional resources and instructional design.
- Conducts demonstration lessons to ensure that all teachers have been trained and supported in advanced levels of small group instructional delivery, and on Universal Design for Learning (UDL) practices.
- Assists intervention staff in preparation and pacing for instruction.
- Creates a site based intervention menu for ELA, math, behavior and SEL.
- Participates in collaborative grade level meetings and/or staff meetings to assist in the analysis and use of assessment data to improve student achievement.
- Assists grade level teams in setting goals for improved instruction.
- Meets regularly with the principal, Team Building, Regulation, Acceptance, and Community (TRAC) teacher, and school psychologist to review assessment data and to assess outcomes of established goals.
- Assists with behavior and restorative intervention supports.
- Schedules SST meetings in collaboration with the site principal.

- Participates in SST, 504 and IEP meetings, as necessary.
- Serves as school site state testing coordinator.
- Prepares forms, records, and assessments as directed.
- Performs other related duties as assigned.
